We have distributed \$202,000 in grants amongst 22 organizations in Puerto Rico that work with women, girls, and non-binary
populations. Among the organizations we have helped, many were emergent organizations. These organizations need strong
support for their organizational structure, which is our main focus in funding. The board finalized the strategic plan, in which we
defined our funding structure and our goals for the next three years. We began the process of solidifying our own organizational
structure, by hiring our first executive director and other staff to run our programs.
