We also developed a more robust strategic and development plan to look forward to the growth of the Foundation in 3 the next years. The Foundation also developed a Grantmaking Guideline with a focus on supporting emerging organizations outside the San Juan area, who need to build their own infrastructure.

program management among others. The Foundation hired an Operations Officer to support the operational infrastructure and continue building the policies and protocols of the organization. This year, the Foundation also completed a new strategic plan for the next three years in a participatory process that included grantee partners, funders, and community leaders.
