During the reporting period, Fundación de Mujeres en Puerto Rico distributed \$437,000 in grants to ten community-based organizations, two of which were fiscal agents for three emerging organizations, bringing the total to 11 grantees. Organizations providing services to women and girls, and other vulnerable populations across Puerto Rico. Grantmaking efforts were implemented throughout the archipelago, including the island municipalities, with attention to broad geographic distribution. Support included unrestricted and operational funding, as well as capacity-building and technical assistance designed to strengthen organizational effectiveness and sustainability. The Foundation also continued to enhance its internal systems and controls, with particular emphasis during this period on financial management and transparency. In addition, the Foundation participated in national and international philanthropic forums, sharing perspectives from Puerto Rico and contributing to broader discussions on strategic grantmaking in contexts affected by economic and environmental challenges.
